- 4.3** To be considered an entry in the event, a boat shall complete all registration requirements and pay all fees.
- 4.4** Late entries will be accepted at registration on 22nd October 2022
- 4.5** Skipper and/or Helmswoman shall be members in good standing of SA Sailing and of a yacht club affiliated to and in good standing with SA Sailing (or their equivalent in the case of non-South Africans) and legally permitted to compete.
- 4.6** Skipper and at minimum one crew must be female.

## **5 FEES**

Entry fees are as follows:

- 5.1** Regatta entry fee: R 250

- 5.2** Other Fees:

All Entry Fees and Class subscriptions shall be paid prior to the close of Registration. Failure to meet this requirement will result in the affected yacht being recorded as Did Not Compete until such time as the required payment/s is/are made. This changes rule A11 (DNC)

## 7 SCHEDULE

- 7.1** Registration: 22 October 2022, from 08:00 to 10:00 under the Afdak at TSC.
- 7.2** Not Used.

- 7.4** The scheduled time of the warning signal for each day is: 11:00. Any change to this will be posted on the noticeboard by 19:00 the day before racing.
- 7.5** A maximum of 10 races are scheduled.
- 7.6** On the last scheduled day of racing no warning signal will be made after 15:00
- 7.7** From after the Start of the First race on the 22 October 2022 to after the last race on the 23 October 2022 no competitor may slip their boats overnight. Due to damage sustained during racing on the day a competitor can seek consent from the race officer to slip their boat to effect repairs.

## 8 MEASUREMENT

- 8.1** Each boat shall produce a valid measurement / rating certificate. In addition, spot measurements may be taken at any stage during the regatta.

RRS 3 states: "The responsibility for a boat's decision to participate in a race or to continue to race is hers alone." Competitors participate in this event entirely at their own risk. The organising authority will not accept any liability for material damage or personal injury, or death sustained in conjunction with or prior to, during, or after the regatta.

## 12 INSURANCE

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of R200 000.00 per incident or the equivalent.

Each participating boat is encouraged to carry sufficient valid third-party liability insurance to cover any liability arising during the event.
